

# APPLICATION FOR ASSIGNMENT OF OCCUPANCY & USE PERMIT

Dear Claytor Lake Property Owner:

As licensee for the Claytor Project (Project), Appalachian Power Company (Appalachian) has the responsibility and authority to regulate, permit, and monitor uses within the Project boundary (1850-foot elevation).

In order to be considered valid, a permit for **Occupancy and Use** must be assigned to any new property owner(s) upon the sale of transfer of property ownership. Failure to assign an Occupancy and Use Permit to the new owners will result in a revocation of the permit.

Attached are the necessary forms to complete this process. Please note the following requirements:

- 1. The Assignment of Permit must be signed by the current deeded property owner(s) or Appalachian Lessee(s), and the new property owner(s) whose names will appear on the deed after transfer of the property or new Lessee(s). The current property owner(s) (i.e., the sellers) or current Lessee(s) must sign as the "Assignor." The new property owner(s) (i.e., the buyers) or new Lessee(s) must sign as the "Assignee."
- 2. All signatures must be notarized.
- 3. The Assignment of Permit will be recorded with the Pulaski County Clerk of Circuit Court. Please enclose a \$26.00 check made payable to the Clerk of Circuit Court of Pulaski County.
